1. Roll Call

The meeting was called to order by President LeDonne at 6:00 pm.

Members present: Greg Zoellick, Lee Uecker, President Anthony LeDonne, Ron Wells, Michael Bartzen, Scott Adkins

and Wendy Stallings.

2. Pledge of Allegiance

President LeDonne led the pledge of allegiance.

3. Meeting Minutes

Motion by Stallings, seconded by Uecker to approve the March 23, 2021 Village Board meeting minutes.

4. Communications and Public Hearings

A. Village President Report

President LeDonne reported that on Monday, April 19 the Spring StoryWalk®, presented in partnership with the Pauline Haass Public Library, begins at Village Park and continues through Sunday, May 2. The StoryWalk® begins at the trail south of the Village Park tennis courts. Hydrant Flushing begins and runs M-F through April 30. On Tuesday, April 20, the Public Safety & Welfare Committee meets at 6:00 pm in the Civic Center Committee Room. Plan Commission meets at 6:30 pm in the Civic Center Board Room. Parks & Recreation Board meets at 7:00 pm in the Civic Center Community Room. Wednesday, April 21 the Pauline Haass Public Library Board meets at 6:30 pm. Saturday, April 24 the Village will host a Drug Takeback event from 10:00 am to 2 pm at the Sussex Public Safety Building. Residents can drop off used and expired prescription medication for proper disposal by the Waukesha County Sheriff's Department.

B. Public Works Committee

1. Motion by Adkins, seconded by Bartzen to approve of bills for payment in the amount of \$10,381.65.

Motion carried 7-0

2. Motion by Adkins, seconded by Uecker to extend the Silver Spring laterals to the public main in the amount of \$33,000 less the cost of the abandonment of the existing system which is to be paid by the homeowners.

Motion carried 7-0

- 3. Motion by Adkins, seconded by Bartzen to approve of Resolution 21-06 to close the road for the VFW parade.

 Motion carried 7-0
- 4. Motion by Adkins, seconded by Stallings to accept of the bid from Northway Fence including Alternate Item 1 in the amount of \$34,000 plus a standard 10% contingency for a total project budget of \$37,400.

Trustee Adkins stated he was against having a fence in Village Park. He had voted in favor at the committee level, but has since reconsidered his position and is against the aesthetics of a fence in such a prominent place in the community. He would like to see this go back to the Park Board for additional discussion and consideration.

Trustee Bartzen stated that he has some of the same concerns as Trustee Adkins.

Trustee Wells stated that a large number of residents came to the Park Board asking for a fence to be put around the pickleball courts so they don't have to chase after balls in the wet grass and to protect the court.

Trustee Stallings stated that she agreed with Trustee Adkins. She would like to see if other parks could be considered for use for pickleball. She thinks that the fence would mess with the visibility of The Grove.

Mr. Smith stated that the Village Board may want to reconsider sending this item back to the Park & Recreation Board to have additional discussion about the fence and consider additional input from the pickleball group. Mr. Smith also stated that if action was not taken tonight on these bids, that they would no longer be good, as they expire after 30 days, and would have to be rebid in the future as steel prices continue to fluctuate in price.

Discussion was had about pickleball and tennis courts within the park system and options for future uses of the courts.

Motion by Stallings, seconded by Zoellick to table this item and send it back to the Park & Recreation Board for additional discussion and consideration.

Motion carried 7-0

6. Staff Reports

Mrs. McElroy-Anderson stated that the 2021 Village Road Program is going well and making good progress and are ahead of schedule in some areas.

Mr. Smith stated that the group, Milwaukee Parents, rated The Grove playground as the 14th Best Park in the Milwaukee-Metro area.

Mr. Macy stated that there were no new bills passed into law recently. There is currently a proposed bill circulating that would allow for Village Trustees to work part time for the Village. The Wisconsin Supreme Court over turned the Governor's mask mandate. The Wisconsin Supreme Court also ruled on not forcing the Election Board to purge the voter rolls statewide. There was also a ruling on Open Records requests and contractors in regards to releasing positive COVID cases amongst their staff. There is also a probability that the state will not pass a budget, in that case, the budget would default back to the latest budget passed as status quo.

Mr. Liebert stated today our Senior Dinner Drive Up dinner took place from 4:30 to 6:30 pm. Open Book is scheduled

for May 4 and Board of Review is Scheduled for May 26. There will also be office hours available to meet with the Assessor on April 28 and May 17, from 10:00 am to 6:00 pm both days at the Civic Center.

No one was present who wished to be heard.

8. Old Business

There was no old business to discuss.

9. New Business

President LeDonne thanked Trustee Stallings and Trustee Bartzen for their service to the community on the Village Board and wished them the best.





From: Halie Dobbeck, Parks and Recreation Director Re: Multi-Sport Court Fencing for The Grove

Date: April 23, 2021



In July of 2020, the Parks and Recreation Board was approached by participants (both residents and non-residents) of the recreation Pickleball program with a desire for a fence to be erected around the multi-sport courts at The Grove at Village Park. As a result of these conversations, the Parks and Recreation Board requested that Village Board allocate funding in the 2021 budget process for the fence. Village Board did allocate \$30,000 to this project in the final budget for 2021.

The Park and Recreation board put together a plan for fencing that would accommodate the requests of the Pickleball players and also factor in all necessary maintenance and safety concerns. Staff also met with the Pickleball Advisory Committee (PAC) to discuss the fencing plan. In that meeting the PAC requested that the East and West sides of the fence be 5ft tall (instead of the proposed 4ft) and that a pedestrian access gate be added on the Northeast side (in addition to the existing entrance gate on the South side and the large access gate – for maintenance purposes – on the West side). The PAC preferred the "swoop" fence over a complete 10ft fence surround. These suggestions were all incorporated into the plan and the project was bid in early 2021.

Bids for fencing around the Multi-Sport Courts at The Grove at Village Park were received and opened at 10:00 a.m. on Thursday March 25, 2021. Four (4) bids were received and are listed below.

Base Bid was for Black vinyl coated chain-link fencing, gates, posts, rails (approximately 447 total linear feet, including 5' and 10' heights with swoop transitions of fencing). *See drawing below for example*

Alternate Bid Item 1 is for stripping topsoil and installing traffic bond between courts and fencing.

Alternate Bid Item 2 was for Black vinyl coated chain-link fencing, gates, posts, rails (in lieu of the 5' and 10' heights with swoop transitions of fencing on the East and West sides, install 10' height fencing on the East and West sides).

Staff has reviewed the bids and qualifications of Northway Fence (Menomonee Falls, WI), the low bidder. Based on previous work done within the Village, we find that they are capable of performing the work described in the Contract Documents.

Staff does believe that there was an error in calculation in Patriot Fence's and Munson's Alternate Bid Item 2, however, adjustments still do not make either contractor the low bidder.

The pre-bid estimate for fencing alone was \$30,000 without contingency. Staff recommended to the Public Works Committee on April 6, 2021 that the Multi-Sport Court Fencing project be awarded to Northway Fence for their Base Bid and Alternate Bid Item 1 (\$28,750 + \$5,250 = \$34,000) and further recommended a 10% contingency (\$3,400) for a total allocation not to exceed **\$37,400.00**. The Public Works Committee unanimously motioned to recommend to Village Board the acceptance of the bid.

At the Village Board meeting on April 13, 2021 the Board unanimously motioned to send the fence back to Park Board for reconsideration.

The Parks and Recreation Board met on April 20, 2021 and reviewed the Village Board's recommendation. The Parks and Recreation Board after thorough consideration of various factors and impacts motioned to send the existing fence proposal back to the Village Board with a potential alteration of a green vinyl instead of the proposed black vinyl and to add landscaping around the fence, specifically on the North side, in order to blend the fence into the park more seamlessly. The Parks and Recreation Board directed staff to look into these options and determine if the bid expiring April 25, 2021 could be extended to April 28, 2021.

Staff spoke with Northway Fence and they will honor the bid price until April 28, 2021, but they cannot modify the bid to green vinyl fencing due to manufacturing shortages. In addition, during normal times they charge a 20% upgrade for green. Staff would install the additional landscaping out of existing budgets, but that work would occur after the fence is installed and over 2021 and 2022 growing seasons.

The Park Board's recommendation is to accept Northway's Bid as presented, but have the Park and Recreation Staff add landscaping (particularly to the North side) to help blend in the fencing.

Re: Armory Park Batting Cages Proposal

The Jr. Chargers Baseball Club attended the Parks and Recreation Board meeting on February 16, 2021 with the request to add two batting cages (concrete and turf) at Armory Park between diamonds A1 and A2. Two motions recommending action at Village Board were made by the Parks and Recreation Board.


- 1. Park Board motioned to allow the Jr. Chargers to construct and donate a double-wide batting cage at Armory Park between diamond 1 and diamond 2 pending a site investigation to determine proper drainage.
- 2. Park Board also motioned to recommend that Village Board provide funding for the cages, poles, netting, hardware, and L screens to not exceed \$10,000. Jr. Chargers Baseball Club would be responsible for site investigation of drainage and responsible for presenting a one-page report to staff of the location prior to construction. Staff discretion should be used on location approval or change if necessary. Jr. Chargers would be responsible for the site work, concrete, installation, and all other necessary components to complete the batting cages as presented and donate to the Village upon completion. Jr. Chargers do need to fundraise for the cost of the batting cages.

This project was not budgeted as part of the 2021 process.

Village Board met on February 23, 2021 and tabled the motion on the request that Staff pursue alternative funding opportunities.


On Tuesday April 20, staff was notified by the Sussex Area Service Club that their club had approved a total donation of \$12,325 to fully fund the batting cages (a total estimated cost of \$50,000) in conjunction with the Jr. Chargers. As a result of this funding, there is no immediate impact on Village funds. However, once the construction is complete, the Jr. Charges and Sussex Area Service Club will be donating the structure to the Village for the Village to maintain.

This means the Village will be adding a \$50,000 asset to the park system that will need to be depreciated over a 10-year life cycle (based off of a turf installation). The Village will need to begin in 2022 a depreciation of \$5,000 a year. The Village motion will be to accept the installation and donation of the batting cages at Armory Park and direct staff to starting with the 2022 budget add \$5,000 per year for depreciation and ultimate replacement of the same.
