Re: Plainview Road Water Main

You may recall from the May and June Engineer's Reports that the attempt at directionally drilling the water main along Plainview Road from the railroad tracks to Bluebill Drive was unsuccessful. We have received a price from Neumann's contractor to install the water main using conventional methods and feel that it would be more economical to bid the work in a competitive bid environment. Therefore, Staff recommends that we wrap the construction of this water main into the project to extend water main along CTH VV and bid them together in January of 2022 for construction starting in Spring of 2022.

Re: Wastewater Treatment Plant Automatic Gate: Construction Bids Recommendation

Bids for Wastewater Treatment Plant Automatic Gate were received and opened at 2:00 PM on Wednesday, July 28, 2021. One bid was received and are listed below.

Contractor	City, State	Base Bid Total
Northway Fence	Waukesha, WI	\$35,300

Staff has reviewed the bids and the qualifications of Northway Fence, Inc. the low bidder. Based on previous work done for other municipalities, we find that they are capable of performing the work described in the Contract Documents.

The project was budgeted in the 2020 Sewer Utility Budget for \$30,800 using cash on hand. The cost is a bit higher than originally anticipated, but as we learned with the Park fence bid earlier this year, the commodities market is very volatile at this time and material prices are higher than we could have anticipated when the estimate was done so we feel that the price is reasonable. There is sufficient cash on hand to cover the additional cost.

The work under the Wastewater Treatment Plant Automatic Gate Project includes replacing the existing manual entrance gate at the Wastewater Treatment Plant with a single chain-link slide power gate. The gate will close and lock after an authorized user enters or exits for added site security. There will be a keypad to allow authorized entry and Public Works staff will have garage door opener type devices in their vehicles for ease of access. We will also be adding a small lockable manual swing gate for pedestrian access. The power for the gate will be extended from the plant and will be directionally drilled and installed in a conduit to avoid pavement replacement now and in the future when maintenance is needed. We expect construction to start in September. The contractor will have until November 15<sup>th</sup>, 2021 to complete the project.

#### **Recommendations:**

Staff recommends that the Wastewater Treatment Plant Automatic Gate contract be awarded to Northway Fence per their bid for the project of \$35,300. We also recommend that a contingency of \$3,530 (+/- 10% of total cost), be established for a total allocation of **\$38,830** for this contract.

Re: Salt Purchase 2021/2022 Season

Waukesha County has issued our Salt Agreement. We do this each year. The price of salt is \$85.05 per ton, which is \$2.24 more than last year (about a 2.7% increase). The quantity of salt available to us will remain at 2,100 tons. We only pay for what we use. In the 2020/2021 season we used 1,344 tons. The County purchases salt through the State contract so while the price is up, it is still the least expensive price available to us. Staff recommends that the Board approve the agreement.

Re: Salt for 2021-2022 Season

Dear Village of Sussex, Public Works

Waukesha County will continue with the new way our salt agreements and sales were instituted.

- 1. We will continue to use a 5-year rolling average based on your municipality's use for ordering your salt quantity. This is how county salt is ordered.
  - a. Your current average is 1919 tons.
  - b. You requested 2100 tons for this season.
  - c. Your last season's salt usage was 1344 tons.

Should you exceed your average annual use, the County's current inventory of available salt and salt yet to be ordered will be used to determine if you can purchase more than the allocation.

- 2. Waukesha County will continue to add a storage and handling fee to the salt. This will only apply to salt used and is included in the price agreement.
- 3. All salt picked up will be weighed in tons. Any salt returned must be returned and re-scaled at the Highway Operations Center located at 1641 Woodburn Road, Waukesha, 53188. We have a new certified scale in operation for the upcoming season.

Please review the attached Letter of Agreement carefully. If you are in agreement with its terms and conditions, sign and date both forms, keep one for your records and return the other to us in the enclosed envelope no later than Monday September 1, 2021.

The Village Invoicing by the County will occur on a monthly basis with payment made within 30 days of receipt of invoice. The Village agrees to the above listed amount of salt during the 2021-2022 winter season. The Village will only be billed for actual salt taken and used from Waukesha County sheds. There will be a restocking fee of \$ 10.00 per ton charged to the Village for the return of salt to a County substation. There will be no charge if returned to Main Shop and scaled in and out for restocking. Should the Village require additional salt, the Waukesha County Highway Operations Manager or his designee will negotiate with the municipality. Re: Engineering Monthly Report – August 2021

#### 2021 Road Program

- Construction on Sussex Road and Village Drive is done and both roads are open to two way traffic.
- Miller Way, Waukesha Avenue and Good Hope Road are all essentially complete.
- Sidewalk along the south side of Silver Spring Drive is done. The rest of the sidewalk on the north side is scheduled for July 30<sup>th</sup>. Most of the utility work is done, the rest does not require ground disturbance.
- Hi-Tech Drive pavement will be done this week or early next.
- Pond and Ditch grading in the Industrial Park is scheduled for August.

#### Maple Avenue:

- Contractors have spent a lot of time in the north section of Maple Avenue in the past few months working to improve the lawn restoration. The drought has made grass growth difficult. We're finally at a point where we feel comfortable making final payment for this contract. All remaining improvement to lawns, etc. along all of Maple Avenue will be done under warranty, including replacement of trees this fall.
- We are still waiting for paperwork from We Energies for street light removals on Maple Avenue from Champeny to Good Hope Road. We are told by We Energies that their design work will be done in early September. They also just told us that they cannot remove the Village owned light poles south of Main Street, so we will hire a contractor to remove them.

#### Miscellaneous:

- Valve turning has started in the south half of the Village. Each valve is exercised every 2 years. This practice increases the likelihood that we can turn them during main breaks to isolate the problem area.
- We have finalized the alignment and completed the soil and rock borings for the CTH VV water main west of STH 164. Preliminary plans are expected in the coming weeks.

#### **Developments:**

- Woodland Trails: Sewer and water work is complete and storm sewer work is underway.
- <u>Sussex Preserve</u>: The curb and binder course of asphalt is done. Private utility and sidewalk installation will follow. Top lift of asphalt in all of Sussex Preserve will be placed this fall. Phase 3 utility work continues. Sanitary sewer, water and storm sewer installation is complete.
- <u>Vista Run:</u> Rough grading of phase 1 is done. Sanitary sewer installation is underway. The Developer intends to have lots ready for construction this fall.
- <u>Lisbon TIF (Lied's) Water Main:</u> Plans are approved. Blasting has started. The Town is waiting for DNR approval of the water main along Main Street and Richard Road. The water main construction through the School District property is currently planned for next summer.
- <u>Highlands Business Park Phase 1</u>: Developer is constructing additional storm sewer so that they can adjust the originally proposed pond watershed areas to accommodate proposed development.
- <u>Highlands Business Park Phase 2</u>: The initial review of the road and utility plans, grading plan, and storm water management plan is complete. Construction schedule has not been established yet.
