The meeting was called to order by Village Clerk Sam Liebert at 6:00 pm.

Mr. Macy reported that there was no major action happening right now with the legislature. We are monitoring the workforce housing bill. The legislature may end their session early in January or February in the coming year.

Mr. Liebert reported that we were able to get tax bills out a little extra early this year. Also, Pastor Bob Rodzaj is available this evening for item number 9 if anyone has questions for him.

- 4.A. Village President Report- report on meetings attending and upcoming communications, and recognitions including Successfully Sussex Awards.
- 5.A.1. The Finance and Personnel Committee recommends approval of the December Check Register and P-card Statement in the amount of \$847,049.00. Please see the disbursement summary and registers for additional information.
- 5.A.2. The Finance and Personnel Committee recommends approval of the December Ace Hardware purchases in the amount of \$1,190.90. Please see the disbursement summary for additional information.
- 5.A.3. The Finance and Personnel Committee recommends approval of a Temporary Class B License for the sale of Fermented Malt Beverages and Wine for Hamilton Jr. Chargers Baseball Tournament at Armory Park and Village Park July 22-24, 2022, President Patrick Buchanan. This event is held annually and the Village has had no significant concerns with the event in the past. Please see the application for additional information.
- 5.A.4. The Finance and Personnel Committee recommends approval of the Red Flag Rules 2021 Annual Report. In May, 2009 the Village Board approved the Identity Theft Prevention Program for the Village and the Fire Department in accordance with the Federal Trade Commission's Red Flag Rules which went into effect in June of 2010. One of the requirements of the program is to provide the Board with an annual update of its effectiveness and any identity theft incidents. Since the last report covering 2020, no instances of identity theft have been reported. Please see the attached memo from staff for additional information.
- 5.A.5. The Finance and Personnel Committee recommends approval of Resolution 22-03, the 2021 Annual Budget Amendment. The Village on an annual basis in order to follow best financial practices provides a budget update resolution at the end of the fiscal year to reflect changes (additional/lower revenues, adjusted expenses) within the budget. The budget is balanced and saw \$474,000 in additional revenue and expenses (mostly related to Development activity). The Village also has an audit done annually to ensure the financial data is correctly represented, which is usually reported in June. The Village does predict a surplus again, which is finalized during the audit process. That surplus per policy is directed to the cash capital fund to close cycle gaps that remain in that fund to limit future borrowing. Please see the attached resolution for more information.

- 5.A.6. The Finance and Personnel Committee recommends approval of Resolution 22-04 Designating Public Depositories and Approving Other Financial Institutions for Investment. Village policy requires that the Village Board designate one or more public depositories organized and doing business under the laws of this State or Federal Law and located in this State, in which the Village Treasurer shall deposit. The Village annually updates this resolution. Please see attached resolution for additional details and information.
- 5.B.1. The Public Works Committee recommends approval of bills for payment in the amount of \$109,548.93. Please see the disbursement summary for additional information.
- 5.B.2. The Public Works Committee recommends approval of the purchase of E-Series Water meters not to exceed \$85,000. The first round of purchases in 2022 will be \$63,105. The large meter change-out is scheduled over the next fours years with about \$85,000 each year. Funds come from the water utility and are depreciated back against the Sewer Utility for its share of costs over time. The old meters are at their end of useful life and the new meters give greater flexibility of operations and will ensure proper billing for these larger water users. Please see the memo from PW Foreman Jon Baumann for more information.
- 5.B.3. The Public Works Committee recommends approval of bid from Langer Roofing for \$441,320 with a 10% contingency authorization for the replacement of roofs at the WWTF and Well #5. That includes replacing the Well #5 roof with a higher quality system that will last twice as long. The Village received 2 qualifying bids and Langer is the lowest responsible bidder. Funds for this project come from the sewer and water utility respectively. The roofs are leaking and are in need of replacement. Please see the memo from Assistant PW Director Dennis Wolf for more information.
- 5.B.4. The Public Works Committee recommends approval of Resolution 22-1 setting forth the Main Street road closure for the Lions Daze Parade on July 17, 2022 and allowing the use of Village equipment for Lions Daze Special Event in 2022. This event has been held for decades in the community and the annual request for the parade street closure and use of Village equipment is similar as in years past. Please see the request and resolution for more information.
- 5.B.5. The Public Works Committee recommends approval of Resolution 22-2 Accepting the Improvements and starting the warranty period for the Sussex Preserve Subdivision. State Law now limits a warranty period to 14 months so this acceptance resolution follows the State Law period. A majority of the improvements in Phase 1 have been in longer than 14 months and the Developer just waited to request acceptance at one time with all of the improvements through the 3 phases so some items have already concluded the warranty period. The letter of credit will be reduced according to law with adoption of the resolution as well. The letter of credit will be further reduced with the introduction of a cash surety for the remaining street trees. Please see the resolution and memo from Village PW Director/Engineer Judy Neu for more information.
- 6.A. The Village Board asked staff to do more regular surveys of the public on various topics. Those results will be provided to the Village Board throughout the year. The first one was completed on Trick-Or-Treating as that topic received lots of interest from the public. Since the Village Board sets Trick-or-Treat times and there was a lot of interest, staff has provided an outline on the results and the Village Board may want to take action based upon the feedback.

RESOLUTION DESIGNATING PUBLIC DEPOSITORIES AND APPROVING OTHER FINANCIAL INSTITUTIONS FOR INVESTMENT

Re: Purchase of E-Series Water Meters

The Village of Sussex Water Utility is beginning a 4-year program to replace all water meters 1" and larger. With this program the Water Utility will replace meters/transmitters that are outdated and beyond their life cycle with newer technologies. As the mechanical components of the old meters wear down, the accuracy of the meter is also affected. In most cases the meter slows down which means lost revenue. The new meters are made of stainless steel which means they are "lead free" and there are no moving parts that wear out.

Staff is requesting to purchase:

30 - 1" E-Series meters w/ORION ME transmitters @ \$385.00 each = \$11,550.00

 $30-1\frac{1}{2}$ " E-Series meters w/ORION ME transmitters @ \$835.00 each = \$25,050.00

15 - 2" E-Series meters w/ORION ME transmitters @ \$1,105.00 each = \$16,575.00

3-3" E-Series meters w/ORION ME transmitters @ \$3,310.00 each = \$9,930.00

Total Cost: \$63,105

A total of \$85,000 was budgeted to purchase these meters as part of the 2022 Water Utility Budget. Additional meters may be purchased later in the year with remaining budgeted funds.

Re: WWTP/Well #5 Roof Replacement

The roofs over the lunch room/shop and filter building garage at the wastewater treatment plant and the roof at Well #5 need to be replaced. All of the roofs have leaks, and the membrane is showing significant signs of aging with holes and seam separation in many areas. An estimated price for replacement was received in 2021, and was approved by the Sussex Village Board. The estimated costs were \$205,000 for the wastewater treatment plant roofs, and \$75,000 for Well #5.

During the bidding process, staff requested one bid for the wastewater plant roofs, and two bids for the Well #5 roofs from contractors. The style of replacement at the wastewater treatment plant is an asphaltic roof, and at Well #5, the base bid is for an EPDM rubber membrane, with an alternate bid for an asphaltic roof. The initial cost for an asphaltic roof is higher, however it has a 30-year warranty versus a 15-year warranty for an EPDM membrane roof. Staff wanted to compare the costs of both styles of replacements to determine if similar scopes of work would result in a cost savings for the water utility.

The following bids were received:

A third bid was incomplete, and rejected from consideration.

Due to material and labor costs rising significantly since last July, the cost of the project has exceeded our estimate. Staff would like to present four options for consideration.

1. Award the bid to Langer Roofing, who submitted the lowest base bid and alternate bid. While the alternate bid would add \$25,785 in up-front costs, it would save \$174,500 in a longer warranty and a better-quality roof. For this option, staff recommends accepting the alternated bid of \$441,320, allocating additional resources to cover the extra costs. Staff would recommend adding a 10% contingency for unforeseen repairs, at \$44,132, for a total cost of \$485,452.

- 2. Rejecting all bids and re-bidding later with the hope that supply chain issues abate, possibly lowering material costs. Our consultant doesn't project a stabilization in costs until 2024 due to higher than normal demands in the roofing industry.
- 3. Accepting the scope of work for the wastewater treatment plant, and re-bidding one roof replacement at Well #5. The remaining roof sections at Well #5 would be budgeted in 2023.
- 4. Rejecting all bids and re-bidding with a reduced scope of work. The reduced scope of work would be to bid one roof at the wastewater treatment plant, and one section of roof at Well #5. The remaining work would be budgeted for 2023.

Re: Sussex Preserve Subdivision – Phases 1, 2 and 3: Acceptance of Improvements

The Developer of the Sussex Preserve Subdivision has completed the construction of public improvements in Phases 1, 2 and 3 of the development. Staff has inspected these improvements and finds them to be acceptable.

Improvements included:

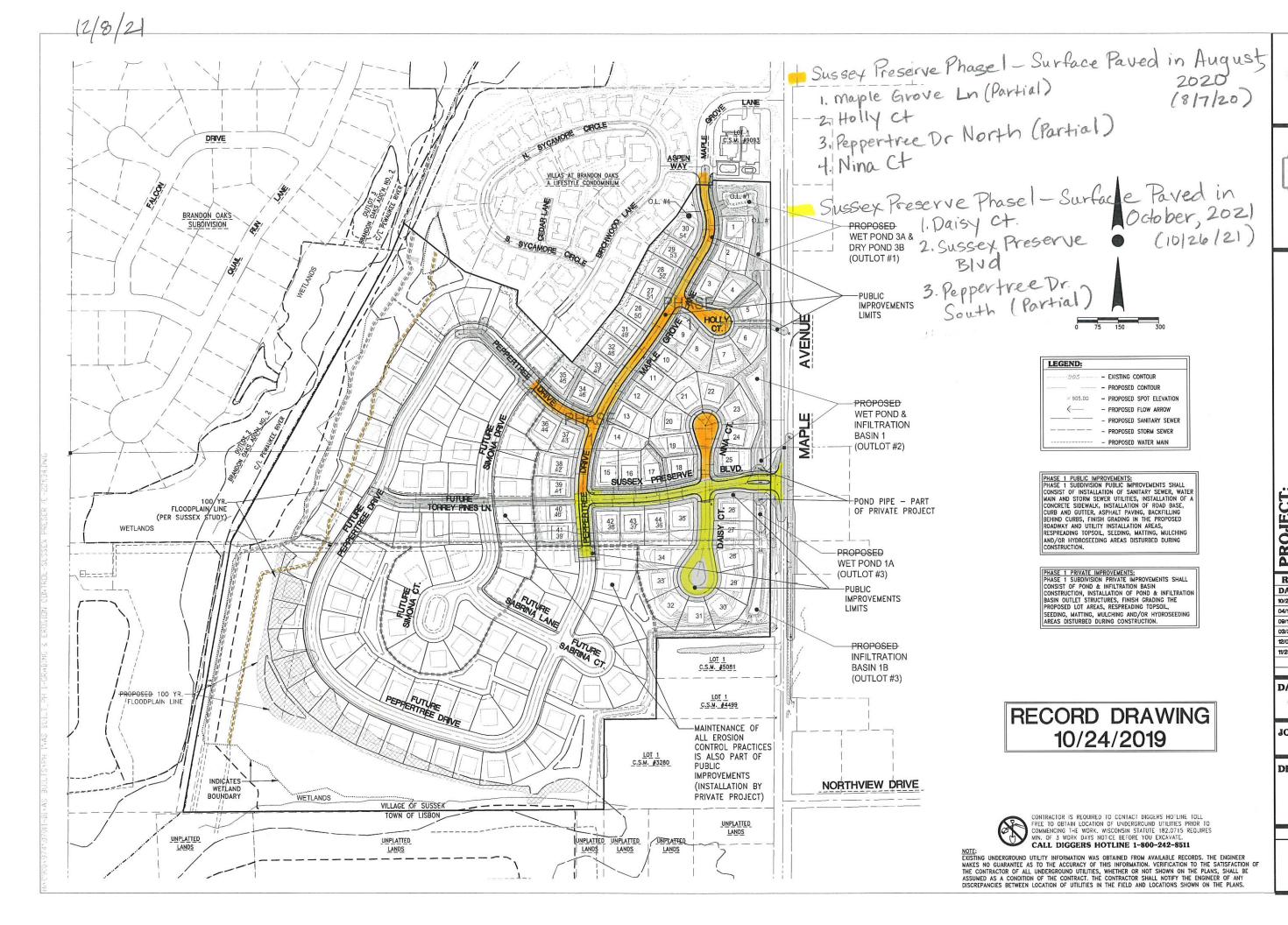
- Sanitary Sewer
- Storm Sewer
- Water Mains and water laterals to the curb stop
- Stormwater Management facilities
- Public streets, curbs, sidewalks and paths
- Street lights
- Street signs and traffic control signs
- Street trees

Staff recommends that the Committee recommend acceptance of the Public Improvements in Phases 1, 2 and 3 of the Sussex Preserve subdivision to the Village Board.

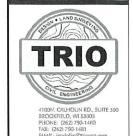
Street tree installation has been taking place after each of the homes is constructed. Because there are vacant lots throughout the development, not all of the street trees have been planted. Therefore, Staff recommends that the Developer provide cash surety for the remaining street trees within the development to cover the cost of the street trees. This surety would be reduced from time to time as the trees are installed.

Section 236 of the State Statutes only allows the letter of credit to be held for 14 months. The majority of the improvements in Phase 1 were built in 2015 and 2016, including the binder course of asphalt. The surface course of asphalt was installed in August 2020 with the exception of Sussex Preserve Boulevard and Peppertree Drive south of Sussex Preserve Boulevard which was used as access for construction of phases 2 and 3 and was paved on October 26, 2021. Therefore, Staff recommends the following:

- Require the Developer provide cash surety for the remaining street trees within the development.
- The only warranty for Phase 1 would be on Sussex Preserve Boulevard and Peppertree Drive South (+/- 175 feet) and that warranty should be 14 months.
- Release of the entire letter of credit for Phase 1.
- Require a 14 month warranty for the improvements in Phases 2 and 3.
- Reduce the letter of credit for Phases 2 and 3 down to 10% of the total subdivision improvement costs for those phases, less the cost of the street trees once the cash surety is in place.

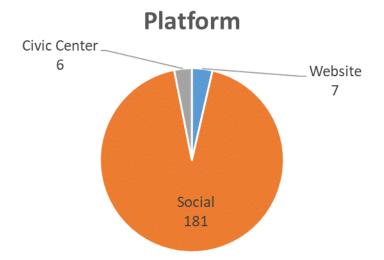

Re: November Community Survey Results - Trick or Treating

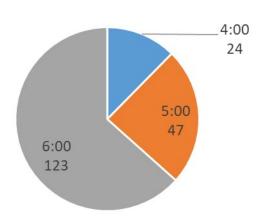
The November pulse survey was posted on Friday, November 12th on social media, the website, and in the Civic Center. The Village received 194 responses, which are summarized below. Respondents were asked about trick-or-treating times. In the past trick-or-treat in the Village of Sussex has taken place from 6 to 8 p.m. on the last Saturday of October.

Staff is looking for direction from the Board as to when they would like to hold trick-or-treating in 2022.









Is there anything else you would like to share?

I think 5:00 start time is a safe compromise so that there is an hour of daylight trick-ortreat for younger kids and so costumes are visible to be enjoyed! This also then leaves an hour of dark time for older/school-age kids to have fun!

Regarding length of time: we live in Centennial Oaks and there is no way I will have enough candy to accommodate all of the trick-or-treaters we would have if the window was 3 hours long! We get lots of kids trick-or-treating in our neighborhood which I LOVE, but we typically run out of candy by about the 90 minute mark! I purchase as much as we can afford, but it still doesn't last:)

Ensure that the non social media web site and social media posts are in sync and have the same information posted at the same time. Many citizens are not on social media and it would be bad judgment to assume that they are.

Have on oct 31

Don't need more than 2 hrs, keep tradtion tradition. It's always been at night. Move it to afternoon for some whiners, I will stop giving out candy. For little kids,how much candy are they eating? Give me a break....it's the parents consuming most if it. Just leave this alone, don't need more time for non community kids to come out here and raid candy as well....

I think it is a good idea to coordinate with neighboring communities if possible. For example, we are 4 houses away from Pewaukee and kids come early since they don't know the cutoff.

Safety was a huge issue this year. There were tractors pulling wagons of people. Kids were running into the streets and people were just congregating and obstructing traffic. These things were seen on Clover Drive. More patrolling and assistance with crowds is needed

Please keep at night, so much more fun!

I don't have kids but we give out candy always and if it has start time earlier than 5 we might not be able to give out candy then.

It is 1 of the safe communities that can actually do nighttime trick or treat, please don't change it.

Slightly earlier times will be more friendly to younger children, who are the majority of those participating.

Blocking off streets of most popular subdivisions would be amazing! So unsafe since so many yahoos still drive around during trick or treat

I just wanted to share that I really like trick or treat being the Saturday before Halloween. It gives us a chance to hand out candy and host a couple friends over all still while having the opportunity to head over to my mom's house on Halloween and spend time with her too. I also understand that some parents of young children want daytime hours, so I think 5 would be fair for the littles to go out when it's still light and the bigger kids can still enjoy the after dark time. As a parent it's honestly easier for us to go after dark because it's easier to see porch lights being on which is an indicator on if a house is participating. Thanks for asking!

Don't change it.

Leave it the way it has been

Two hours is long enough. Some subdivisions are jampacked and chaotic. Vehicle travel is next to impossible for those two hours.

I view trick or treating as a way for the community to mingle, come together and in some cases meet for the first time. Ultimately it is for the kids and their safety should be at the forefront. Having an hour in daylight, at the very least, allows younger kids to participate without the ramped up scary productions in the darkness of the evening. 5 - 8 or 4 -7 are a good compromise. I appreciate it staying on the Saturday on not on Halloween night.

If you start at 5PM, younger kids can go for an hour while there is daylight. Still plenty of time for others that want the darkness.

2hrs is plenty. I get repeat trick or treaters after the 1st hour and turn them away. The 6pm start time is perfect as the sun is setting.

We definitely do not need a 3 hour window. Kids can barely make it for the full 2 hours and get SO much candy as it is! (my kids are 10 and 8).

Also, in terms of handing out candy, I don't think I'd have enough to supply over 3 hours so it's likely I'd be done for that 3rd hour. I think you might find houses doing the same, so then you have kids out walking with many houses done handing out.

I love everything about the current 6-8 time and always on a Saturday.

Keep the tradition. Don't do it over dinner hours. Neighboring communities, like Menomonee Falls, have earlier times if people prefer the daylight.

Earlier time to allow young kids in daylight and still some night time.

Match it with the Lisbon window to avoid confusion

It would be so amazing to have at least an hour of light for people with kids, and since lots of subdivisions don't have sidewalks! Please and thank you!

Trick or treat is at its best in the dark, even with little ones!

The trick-or-treat window should be left as it currently exists as I believe the kids and parents who participate enjoy it.
