#### 6. Staff Reports

Ms. McElroy-Anderson gave an update on the citizen survey about Trick-or-treating. Based on those survey results staff will keep Trick-or-Treating hours the same for 2022. The village has also posted the Finance Director Position and Community Development Director Positions. If anyone knows of retirees or people looking for a second job, we need help during the summer and encourage people to apply.

Trustee Adkins recommended that some of the lawn mowing or park jobs be made available only during the weekend to increase the pool of applicants looking for a second job.

The SAFER Grant was released, a grant which helps offset fire department costs. We'll be working in the next three weeks on submitting our application. The library spark session is happening on Thursday and Friday and we strongly encourage the board and public to attend and give their input. This process is critical to the future of the library and what the building will look like.

Mr. Smith reported that the Pickle ball Open House will take place February 2, 4:00 pm – 7:00 pm at the Civic Center. This will be an opportunity for the community to come and view different options to address the growth of pickle ball in Sussex. The ice rink is open. During normal hours the vestibules and restrooms are open for warming, 8:00 am – 5:00 pm.

Mr. Macy stated that he had no report this evening.

Mr. Liebert reported that AARP tax preparation appointments have begun. The program runs February 14 – April 11. Residents can call 262-246-5200 to make an appointment. There will be three candidates for village trustee for the spring election. Names will be drawn this coming Friday at 9:00 am for order on the ballot. We are in the final phase of hiring a new Deputy Clerk.
