1. Roll Call

President LaDonne called the meeting to order at 6:00pm.

Members present: Stacy Riedel, Greg Zoellick, Lee Uecker, President Anthony LeDonne, Scott Adkins, Ron Wells and Benjamin Jarvis.

Also present: Administrator Jeremy Smith, Attorney John Macy, Assistant Village Administrator Kelsey McElroy-Anderson, Interim Clerk Jennifer Moore, and members of the Public.

2. Pledge of Allegiance

President LaDonne led the pledge of allegiance.

3. Meeting Minutes

Motion by Adkins seconded Jarvis by to approve the April 12, 2022 Village Board meeting minutes.
Motion carried 7-0.

A. Village President Report.

Saturday Arbor Day fun run

1. Village President LaDonne read aloud the Village of Sussex Arbor Day Proclamation declaring April 29, 2022 as Arbor Day in the Village of Sussex, Wisconsin.

B. Public Hearing on the Rezoning Ordinance No. 880

The developer attended the meeting to discuss the development and answer questions.

John Waldren – Town of Lisbon resident. Does the access to the subdivision go in and out on Richmond Road and what will happen to accommodate? Access points were selected because they represent the safest location for access. This development does not support widening the road because the addition of these 45 residences does not support that. Future development on the other side of Richmond Road might – that would be a policy decision by the Village of Sussex.

Elizabeth Waldren – Town of Lisbon resident. Developed their property as a wildlife corridor – this development will disrupt that corridor. Richmond Road is already difficult to enter 164 and this development will add approximately 100 cars to that. Does not want the property rezoned.

With no more public comments motion by Zoellick seconded by Jarvis to close the public hearing.

3. Motion by Wells seconded by Zoellick to approve purchase of a zero turn mower from Town and Country with the Scag Turf Tiger for \$13,879.00. Motion carried 7-0.

Circulation is still up for the year and there was an update on space needs and facility study.

E. Plan commission

1. Motion by Zoellick seconded by Uecker to approve to the Village Board of Rezoning Ordinance 880 rezoning lands for the Redford Hills Subdivision (Richmond Road) from A-1 to RS-3 with environmental overlays subject to the CSM being recorded, approval and compliance with the conditions of approval of the preliminary plat and the Developer's Agreement, payment of all fees and subject to the standard conditions of Exhibit A. Motion by Zoellick seconded by Adkins to approve the Preliminary Plat for Redford Hills and Developer's Agreement for Redford Hills conditioned on the Rezoning Ordinance being approved, the CSM being recorded, meeting all comments and conditions of the Village Engineer and Village Administrator with the plat and Developer's Agreement and payment of all fees and subject to the standard conditions of Plat Approval. 4.A. Village President Report- report on meetings attending and upcoming communications, and recognitions including Successfully Sussex Awards.

5.A.1. The Finance and Personnel Committee recommends approval of the April Check Register and P-card Statement in the amount of \$2,713,762.48. Please see the disbursement summary and registers for additional information.

5.A.2. The Finance and Personnel Committee recommends approval of the April Ace Hardware purchases in the amount of \$4.99. Please see the disbursement summary for additional information.

5.A.3. The Finance and Personnel Committee recommends approval of placing the 2021 surplus of \$272,000 back into the General Fund Working Capital Account to start to replenish the draw down that occurred with the advanced debt payment that was made in 2022. This action is in keeping with Village fund policy to maintain 1 months operating funds in the working capital fund at all times. The Village dipped below this threshold for the purpose of paying off debt early. The Village will need to add about \$580,000 more back to the fund to meet the Fund policy after this allocation. Please see the memo from Finance Director Nancy Whalen for more information.

5.A.4.A. The Finance and Personnel Committee recommends approval of the 2022 1st Quarter Investment Report. The overall fund balances decreased \$7.4 million from the previous quarter due to tax disbursements to the various taxing entities and payment of \$1.2 million in debt. The average yield went up 0.01% to 0.07% from the 4th Quarter of 2021. Please see the Report from Finance Director Nancy Whalen for more information.

5.B.1. The Public Works Committee recommends approval of bills for payment in the amount of \$488,034.67. Please see the disbursement summary for additional information.

5.B.2. The Public Works Committee recommends approval of purchasing two Chevrolet trucks from Ewald Automotive Group and one plow from Truck & Auto Elegance for a total cost of \$93,354. Please see the memo from Public Works Foreman Scott Ascher for more information.

RE: 2021 Surplus

2021 ended with a surplus of about \$408,000. Of this amount \$136,604 is in the 2022 budget to cover the Finance Director overlap and the phasing in of other positions so there is about \$272,000 available to allocate.

At this time, staff is recommending that the entire amount be placed in the General Fund Working Capital Fund Balance account. The standard in the Village's Fund Balance Policy is that the Working Capital Fund should have funds equal to one month (8.33%) of the following year's budget (approximately \$881,000); however, in 2022 this fund was depleted by \$900,000 when the 2013 debt was called and it is prudent to replenish this fund to help cover any unforeseen cash flow needs.

Any of the \$136,604 that has been set aside for use in 2022 that remains will roll into any 2022 surplus that will be generated.

Highlights of the Quarter:

- ❖ The balances show a net decrease of about \$7.4 million since the last quarter. This is from the January tax payouts and the call of the bonds on 3/31/2022 offset with additional tax collections leading up to the March due date.
- ❖ The rate at the LGIP increased ten basis points (0.10%). Everything else was stable at very low rates.
- ❖ Based on the balances at quarter-end, the average yield for the quarter increased from 0.06% to 0.07% for the fourth quarter.

While the total of investments may seem like a large amount, there are various reserves required by our borrowing instruments. Other funds are set aside for specific purposes as set by the Village Board or Village policies. Funds are categorized as follows:

Re: Pickup Trucks

The time has come to replace pickup trucks in the Street and Parks Departments. The Street Department will be replacing a 2011 Ford F250 and the Parks Department will be replacing the 1999 GMC Sierra. Both vehicles are experiencing increased maintenance issues. The cost of the new trucks will be covered by the depreciation fund.

Typically, we obtain 3 quotes for a purchase like this however, Ford and Ram are not releasing prices or accepting orders for trucks through the government pricing system at this time. Ewald Automotive Group, who is the dealer for all makes with government pricing, does not know when Ford or Ram will be releasing pricing or accepting orders. This leaves us with only one brand and one quote, Chevrolet. Three quotes were also obtained for the purchase of a plow for the Streets truck. The current plow on the F250 will not fit onto the new truck.

Truck

1. **Chevrolet: \$43,427**
2. **Ford: N/A**
3. **Ram: N/A**

Snow Plow

1. **Truck & Auto Elegance: \$6,500**
2. **Brake & Equipment: \$7,050**
3. **L&K Specialties: \$7,000**

Once the new trucks and plow arrive, the old trucks and plow will be put up for auction on Wisconsin Surplus website and the proceeds will be returned to the depreciation fund.

Funding for the purchase of these two trucks and one plow was approved in the 2022 Budget. \$35,000 was budgeted for each truck and \$5,500 was budgeted for the plow for a total allocation of \$75,500. When the budget was prepared, no one could have predicted the volatility and cost increases that have recently plagued the automobile and steel industries. The cost of the trucks and the plow have increased over the last 6-8 months. Sufficient funds are available in the depreciation fund to cover these purchases.

Recommendation

Staff recommends purchasing two Chevrolet trucks from Ewald Automotive Group and one plow from Truck & Auto Elegance for a total cost of \$93,354.
