# Fire Department Highlights:

Matt Travis started full-time on February 16<sup>th</sup> and is currently assigned to Blue Shift with Lt. Bonville and Firefighter/Paramedic Rosecky.

On Thursday, March 24th, the Wisconsin Department of Safety and Professional Services (SPS) completed an audit of our fire department. This was the first time that this has been completed for the Sussex Fire Department since December 4, 2018. SPS Evaluates us on the following 10 items every 3-4 years:

- The fire department is organized to provide continuous fire protection in the city, village, or town and has a designated chief. §101.575 (3) (a) 1. Wis. Stat.
- A current roster of active fire department members. SPS 314.01 (13) (d).)

- Time, date, and location of alarms to buildings, and the number of firefighters responding. SPS 314.01 (13) (d).
- Number, duration of, and attendance at fire department meetings. SPS 314.01 (13) (d).)
- Number, duration of, the topic of, and attendance at fire department training sessions. SPS 314.01 (13) (d).)
- Number, duration of, the topic of, and attendance of fire department members at public fire education-related activities. SPS 314.01 (13) (d).)
- Documentation that 2% fire dues funds are used according to statutory requirements. §101.575 (6) (a) Wis. Stat.
- The fire chief's record/list of the public buildings and places of employment within the territory of the fire department for inspection purposes. SPS 314.01 (13) (b) 3, SPS 314.01 (b) 5, SPS 314.01 (b) 6, Note, SPS 314.01 (b) 7.
- Reports of fire inspections performed. SPS 314.01 (b) 8., §101.14(2) (a). Wis. Stat.
- Record keeping of fire and other emergency responses occurring within the jurisdiction. NFPA 1 (2012) 1.11.3.1. Record keeping and reporting of fires filed with the U.S. Fire Administration (National Fire Incident Reporting System. SPS 314.01 (11) (a) 1., §101.141. Wis. Stat.
