# 5. Comprehensive Outdoor Recreation Plan (CORP) Update

Dobbeck updated the board about the current information gathering she is completing with our consultant. Dobbeck presented question concepts for the board to share thoughts on for the CORP survey that will be sent to random households in the Village. More details will be coming soon as the plan continues to develop.

# 6. Park & Recreation Director's Report

Dobbeck shared the following information:

- -George Washing Burr Oak Tree: The tree lost its last two major limbs in a recent storm. The remaining branches will be removed. The parks team is taking care to save as many parts of the tree as possible to repurpose in the future.
- -Vista Run Park: As of 4/14/23 we own the park land in the Vista Run Subdivision. Design will likely begin this fall.

- -Girl Scout Gold Project Little Free Libraries potential locations have been marked in Stonewood Estates and Stone Family Park (Lisbon) and should be installed the 2nd week of May.
- -Splash Pad Shade Concrete patio work is complete and final shade installation should happen in the next few weeks.
- -Memorial Day Our goal is to have all of our parks ready for Memorial Day weekend. We try to open all bathrooms, bubblers, etc. earlier than that, but doesn't always happen. This also includes court nets.
- -Armory Park Restrooms The makeover is complete and looks great. The Parks team sanded the partitions and stained them as well as painted the floors.
- -Grove Floors Are getting redone in the first week of May.
- -June Neighborhood Meeting Coldwater Creek: Will bring tentative ideas to May meeting for your input and consideration. Will host neighborhood meeting to get thoughts on the developments.
