#### 1. Roll Call

 Consideration and possible action on the minutes from the September 13, 2023, meeting. Motion by G. Zoellick, Seconded by R. Johnson to approve of the March 21, 2023, meeting minutes.

#### 3. Comments from Citizens Present No citizens were present that wished to be heard.

### 4. Introduction of Gary Bohlmann

Mr. Bohlmann introduced himself and gave a background of his history of being a longtime resident of Sussex.

### 5. Discussion of Budget and Request for Additional Funds and Possible Action

Vanderpoel shared the sponsorship numbers from 2023 and annual giving from the Actively Aging Committee. After reviewing the numbers Vanderpoel asked the committee to continue the following: Holiday Swag (\$500), Concert on the Plaza, formally Rock-a-thon (not to exceed \$500 in coupons) Senior Scholarships (not to exceed \$2500) and Bingo (\$1,200). Vanderpoel asked if the \$300 set aside for piano tuning could be switched to Lobby parties since the piano is no longer used. Vanderpoel also requested \$200 for craft classes to help with the cost of supplies and to increase the Dinner Parties to by \$800 to keep up with the high cost of food. Vanderpoel also mentioned that she would like to buy new BINGO cards and a digital machine since the cards currently being used are old and worn out. The new BINGO set would be \$100.00.

There was also discussion about increasing the event fees. Strong and Bohlmann both agreed since the cost of living has increased it makes sense to increase fees for events. Especially since there hasn't been a fee increase since 2019.

Waltz made a motion for the following: continued giving to the remain the same for Swag, Concert on the Plaza, Rock-a-thon, Senior Scholarships and BINGO. To increase the dinner/tasting party amount to \$1,800 and switch the \$300 for piano tuning to Lobby Parties as well as \$200 for crafting classes and \$100 for a new BINGO set. Lastly, to increase the fees for dinner parties and events so the new fees would be \$20 for Tastings and \$15 for dinner parties. Motion by J. Waltz seconded by G. Zoellick

Motion carried 5-0

Vanderpoel went over several successful events from September 2023 – January 2024 and upcoming events for Adults Over 50.
