**1. Roll Call**

(Adkins, Jarvis, Riedel, LeDonne, Zoellick, and Wells voted no) Motion failed 1-6

Motion by LeDonne, seconded by Uecker to approve inclusion of a new park shop in the 2025 Village budget.  
Motion carried 7-0

Motion by LeDonne, seconded by Uecker to approve inclusion of The Ridge Pavilion at Village Park in the 2025 Village budget. (Riedel, Adkins, and Zoellick voted no) Motion carried 4-3

Motion by LeDonne, seconded by Uecker to approve raising the fire inspection fees beginning in 2025.  
Motion carried 7-0

Motion by LeDonne, seconded by Riedel to approve a wheel tax beginning in 2025.  
(Adkins, Jarvis, LeDonne, Zoellick, Wells, and Uecker voted no) Motion failed 1-6
